5. That those workers deployed/shall the deployed by the deponent and performing the same & similar kind of work as being done by the worker(s) directly employed by the principal Employer are being/shall be paid the same wages as applicable to the directly employed worker(s) of Principal Employer.
6. That the deponent undertake that each and every worker deployed by the deponent is/are being/shall be paid not less than the minimum rates of wages fixed for their category of employment form time to time by the Govt. of NCT of Delhi under the provisions of Minimum wages Act, 1948 including overtime/weekly of etc. and it shall be paid through the account payee cheque/ECS/Bank Transfer (other than workers engaged in construction work/daily paid). The Payment of wages will be made in the presence of authorized representative of the deponent, and duly verify by him/her.
